No parking is allowed at the end of each road unless discussed amongst themselves by the homes effected and for a limited time if that. No extra parking is allowed next to each property for excessive time. It is dangerous and not courteous to the other owners. It is also important that the common area gate not be blocked on the street to allow others to visit it and to allow our landscape company to enter.
